Conformity assessment tasks may include, but are not limited to, testing, inspection, or certification. The program, institution, or agency is assessed by an external panel against established criteria.

1. The ICHCC is obligated to ensure all Standards from ANAB are maintained.

3. The ICHCC is obligated to ensure that qualifying standards to sit for the CLCP and CCLCP examinations are clear, apply to all applicants equally regardless of formal training, their credentials, and their years in in their health care practice.
4. The ICHCC is obligated to present to ANAB in their annual assessor audit visit, standards that are required and maintained.
5. The ICHCC is obligated to ensure that the CLCP and the CCLCP remain the gold standard in life care planning certification and continues to be highly respected throughout the health care industry.
